I've reviewed your production. Thank you.

1. Please provide the three PDFs attached to the September 25, 2018 email from Don Green to Mike Darga. This was omitted.
2. Please provide the PDF attached to the October 5, 2018 email from Brent LaVanway to Mike Darga. This was omitted.
3. Please provide the PDF attached to the October 8, 2018 email from Mike Darga to Don Green et al. This was omitted.
4. Per your 12/21/18 correspondence, on the basis of "privilege," you refused to produce the two following categories of documents:
  - a. Six emails between Jennifer Elowsky and Mike Darga (and, sometimes, "others").
  - b. Two Emails between Mike Darga and yourself.

The emails in category (b) are plainly attorney-client privileged and I do not seek those.

However, I contest your designation of "privilege" as category (a). Presumably, you're asserting attorney-client privilege.

As has been made clear in this litigation, Mike Darga and HRC are not represented by Milford or by Jennifer Elowsky. Please promptly provide the communications between Jennifer Elowsky and Mike Darga. To the extent she copied Milford personnel on the communications, she waived privilege. In any event, neither HRC nor Darga has standing to assert privilege regarding communications between Ms. Elowsky and Milford.
