

**CHARTER TOWNSHIP OF MILFORD  
ZONING MAP AMENDMENT  
ORDINANCE NO. 156-A-189**

AN ORDINANCE TO AMEND THE ZONING MAP FOR THE CHARTER TOWNSHIP OF MILFORD, REFERENCED IN SECTION 32-98, MAP, OF DIVISION 1, GENERALLY, OF ARTICLE III, DISTRICT REGULATIONS, OF CHAPTER 32, ZONING, OF THE CODE OF ORDINANCES FOR THE CHARTER TOWNSHIP OF MILFORD, IN ORDER TO INCORPORATE THE REZONING OF A PORTION OF CHILDS LAKE MOBILE HOME PARK FROM R-1-R, RURAL RESIDENTIAL, TO R-3, MOBILE HOME RESIDENTIAL, AS SET FORTH BY OAKLAND COUNTY CIRCUIT COURT CONSENT JUDGMENT.

**THE CHARTER TOWNSHIP OF MILFORD ORDAINS:**

**Section 1. Amendment.**

The Zoning Map for the Charter Township of Milford, as referenced in Section 32-98, Map, of Division 1, Generally, of Article III, District Regulations, of Chapter 32, Zoning, shall be amended to incorporate the rezoning of the entire NW ¼ of Section 36, Town 2 North, Range 7 East of the Township from R-1-R, Rural Residential, to R-3, Mobile Home Residential, as set forth by the Second Stipulated Amendment to Consent Judgment, Case No. 73-106285-CX, dated March 15, 2017, illustrated on the attached Zoning Map.

**Section 2. Savings Clause.**

That nothing in this Ordinance hereby adopted be construed to affect any just or legal right or remedy of any character nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

**Section 3. Severability.**

The various parts, sections and clauses of this Ordinance are declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected.

**Section 4. Adoption.**

This Ordinance is hereby declared to have been adopted by the Charter Township of Milford Township Board at a meeting thereof duly called and held on the 17th day of May, 2017, and ordered to be given effect upon publication as mandated by Charter and statute.
