

**CHARTER TOWNSHIP OF MILFORD
ORDINANCE NO. 222
BUSINESS LICENSING REPEAL**

AN ORDINANCE TO AMEND CHAPTER 8, BUSINESSES, OF THE CODE OF ORDINANCES FOR THE CHARTER TOWNSHIP OF MILFORD, BY REPEALING ARTICLE II, LICENSING, IN ORDER TO ABOLISH THE REQUIREMENTS PERTAINING TO BUSINESS LICENSING WITHIN THE TOWNSHIP.

THE CHARTER TOWNSHIP OF MILFORD ORDAINS:

Section 1. Amendment.

Article II, Licensing, of Chapter 8, Businesses, of the Code of Ordinances for the Charter Township of Milford, shall be repealed in its entirety.

Section 2. Repealer.

This Ordinance hereby repeals any ordinances in conflict herewith.

Section 3. Savings Clause.

That nothing in this Ordinance hereby adopted be construed to affect any just or legal right or remedy of any character nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

Section 4. Severability.

The various parts, sections and clauses of this Ordinance are declared to be severable. If any part, sentence, paragraph, section or clause is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of the Ordinance shall not be affected.

Section 5. Adoption.

This Ordinance is hereby declared to have been adopted by the Charter Township of Milford Township Board at a meeting thereof duly called and held on the 15th day of March, 2017, and ordered to be given effect upon publication as mandated by Charter and statute.
