Fees of the Clerk: \$267.80

Only filing fees for a complaint filed in Federal Court are taxable. (See Bill of Costs Handbook, Section II(A)(1), page 2.)

Service Fees: \$64.00

Service fees for witnesses Valerie and David Mamo are not taxable, as their corresponding deposition transcripts were not taxable. (See Bill of Costs Handbook, Section II(B)(1)(c), page 3.)

Court Reporter Fees: \$1,864.65
